

# This is Roosevelt's New Deal!

Here is **How** it was done. (but they had to **TRICK YOU** into **abandoning your Citizenship** and **abandoning your State** and **abandoning your Nation** and **giving up ALL of your unalienable Rights!**)

**Government One** – *reality*  
Where you *believe* you live.

The “true name” is  
**“The United States of America”**  
*Dixon v. United States*, 1 Brock 177, 7 F. Cas. 761 (A.D. 1811) given by Chief Justice John Marshall.  
It is a **republic**, combining **State and National government**, created by **We the People**, Citizens of the several sovereign States in Union, by their Constitution of the United States of America, March 4, **1789**.  
**This Constitution is Paramount Law**, exercising **17 limited enumerated Powers**. (Art. I, Sec. 8 of the Constitution) delegated by the People.  
Article VI, Cl. 3 of the Constitution of the United States of America states, “...the Members of the several State Legislatures, and all executive and judicial Officers, both of the United States and the several States, shall be **bound by Oath** or Affirmation, to support **THIS Constitution**”  
Article I, Section 10 of the Constitution of the United States of America states, “No State shall ... make any Thing but **gold and silver** Coin a Tender in Payment of Debts”  
Article IV, Section 4 of the Constitution of the United States of America states, “The United States shall guarantee to every State in this Union a **Republican** form of Government”  
state – “members of the American confederacy **only** are the states contemplated in the constitution” and “the word state ... excludes from the term the signification attached to it by the writers on the law of nations”. *Hepburn and Dundas v Ellzey*, 6 U.S. 445, 454 (A.D. 1804)  
state – “In the Constitution the term state most frequently expresses the combined idea ... of **people, territory, and government**... a political community of free citizens, occupying a territory of defined **boundaries**, and organized under a government sanctioned and limited by a written constitution” *State of Texas v. White*, 74 U.S. 700, 722 (A.D. 1868)  
**Courts** – The Judiciary Act of 1789 created “**district courts of the United States**” in the several States.  
**Process** – For example, the Constitution of Nevada (October 31, 1864), ARTICLE VI – Judicial Department, Sec. 18, says: The Style of all process shall be “The State of Nevada,” and all prosecutions shall be conducted in the name and by the authority of the same. [i.e., in the name of the People.]  
“... all men are created equal, that they are endowed by their Creator with certain **unalienable Rights**”  
The Declaration of Independence, July 4, 1776  
“The words **“people of the United States”** and **“citizens”** are synonymous terms, and mean the same thing. They both describe the political body who, according to our republican institutions, form the sovereignty, and **who hold the power and conduct the government** through their representatives. They are what we familiarly call the “sovereign people,” and **every citizen is one** of this people, and a constituent member **of this sovereignty**.” *Dred Scott v. Sandford*, 60 U.S. 393, 405 (A.D. 1856) [in other words,  
**You are a sovereign, with unalienable Rights.**]  
These two spheres are **FOREIGN** to one another. If a Man was **BORN in one of the several States** (i.e. the left sphere), then **abandons**

Roosevelt’s “Braintrust” brought together these pieces of legal history to form **The New Deal**.

**March 9, 1933, Emergency War Powers** – One of the first things Roosevelt did was to amend the Trading With The Enemy Act of 1917, from “at war”, to “during time of war or ... **national emergency**”, so he could fight the depression “as if to fight a war”. The “national emergency” he declared is **still in effect today, 75 years later!** Such “war measures” allowed, among other things, the suspension of **constitutionally required** gold and silver coin. see *Juilliard v. Greenman*, 110 U.S. 421 (1884)

**Just one problem** – to commit an act of war upon one of the several States (or upon one of the People of one of the several States) is **the very definition of TREASON**.  
So how can you:  
• **separate the People from their sovereignty?** and  
• **separate the States from their sovereignty?**  
Accomplishing that is ...  
**The New Deal!**

**1872** – The Supreme Court, in the *Slaughterhouse Cases*, 83 U.S. 36 and *United States v. Cruikshank*, 92 U.S. 542 (1875) said, **there are two kinds of citizens in America: Which kind of citizen are you?**  
**See White Paper 1**

**1804** – The Supreme Court, in *Hepburn and Dundas v Ellzey*, 6 U.S. 445, and *State of Texas v. White*, 74 U.S. 700 (1868) said, **there are two kinds of states in America: Which kind of state are you a member of?**  
**See White Paper 2**

**1901** – The Supreme Court, in *Downes v. Bidwell*, 182 U.S. 244, and *Hooven & Allison v. Evatt*, 324 U.S. 652 (1945) said, **there are two “United States: Which “United States” do you live in?**  
**See White Paper 2**

And so, the government (i.e. the politicians) are running a **4-way, compound SCAM** on the American people. Here is the result:

**Government Two** – *the appearance of reality*  
Where you *actually* live.

**Two spheres of political government that do not overlap**  
their jurisdictions are **foreign to one another**

The right sphere can be created under the Constitution in Art. IV, Sec. 3, Cl. 2, “Congress shall have Power to ... make all needful Rules and Regulations” **but only in the Territories!**

**United States of America**  
self described, **never voted on by the People**, apparently created by Congress in 1948, first appears in Black’s Law Dictionary, Seventh Edition, page 1534, apparently operates as a **democracy**, under the United States Constitution, a mere statute, statuzited by Congress in *An Act to provide a Government for the District of Columbia*, 16 Stat. 419, Sec. 34, page 426, on Feb. 21, **1871**.  
Exercises **unlimited, or plenary power**, under Art. IV, Sec. 3, Cl. 2 of the Constitution as “Congress shall have Power to dispose of and make **all needful Rules** and Regulations **respecting the Territory** or other Property belonging to the United States.”  
**This Power is for U.S. territories!**  
**This Power is FOREIGN to the several States.**

- So, how can 300 million Americans be separated from their Sovereignty, their unalienable Rights, their territory and their government and be **converted** into this alternate political sphere? **Only by deception!**
- Deception 1:** The words in the law dictionaries have gradually **been changed** and the People have **accepted it**.
  - Deception 2:** No Oath, wrong Oath, or Oath taken in wrong sphere means **NO proper OFFICE** means **no authority**.
  - Deception 3:** In this sphere, Banks emit **only Federal Reserve Notes**, i.e. **commercial** negotiable instruments. Mere **USE OF** commercial paper **SUBJECTS all users** to the U.C.C and Congress’ commercial power.
  - Deception 4:** With no gold or silver, elected Officers are **not in proper office** because they cannot be PAID, for failure of consideration. Salaries are only *discharged* with **promises** to pay, i.e. Notes, i.e. Federal Reserve Notes.
  - Deception 5:** If government, national or state, comes down from its position of sovereignty, and enters the domain of commerce, and **does business with its citizens**, it submits itself to the same laws that govern private individuals there. (five cases) 292 U.S. 571, 580 (1934); 294 U.S. 330, 352 (1935); 91 U.S. 389, 399 (1875); 536 U.S. 129, 130 (2002); 318 U.S. 363, 369 (1943); **in other words, you are doing business with a private party!! not a sovereign to whom you owe a duty of allegiance to obey!!** This **doing business** is why you always have to **SIGN something, even if they have to coerce your signature under threat of assault, battery, kidnapping and jail, piracy and treason!**
  - Deception 6:** In this political sphere, the federal government and all the state governments apparently all operate as **democracies**. “Democracy, democracy, democracy” is all you hear on television and radio.
  - Deception 7:** state, in Black’s Law Dictionary, Seventh Edition, “The political system of a body of people who are politically organized; the system of rules by which jurisdiction and authority are exercised over such a body of people.” This definition says **nothing** about the sovereign People or the sovereign several States in Union. These states are presumed to be populated by **federal citizens**, or **U.S. citizens**, merely residing, in **federal states**, enumerated but not defined and having **no boundaries**, in 28 USC sections 81 through 111 (including the District of Columbia, which is not one of the States of the Union). They are called “administrative divisions” on [www.cia.gov](http://www.cia.gov) and “**territories**” on [www.usa.gov](http://www.usa.gov), both official government web sites.
  - Deception 8:** **Courts** - 28 USC created “**United States district courts**” to operate **in the territories**. **These federal “courts” displaced** the People’s **national “district courts of the United States”** that previously operated **within the several States** under the authority of the 1789 Judiciary Act.
  - Deception 9:** **Process** - In **this** political sphere, in 28 USC Section 108, “Nevada”, all process **ACTUALLY** runs in the name of “STATE OF NEVADA”, **in spite of** the Constitution of Nevada.
  - Deception 10:** “... it is evident that they [**U.S. citizens**] have **not** the political rights which are vested in citizens of the States. They are **not** constituents of any community in which is vested any sovereign power of government. Their position partakes more of the character of **subjects** than of citizens. They are subject to the laws of the United States, but have **no voice** in its management. If they are allowed to make laws, the validity of these laws is derived from the sanction of a Government in which they are **not represented**. Mere citizenship they may have, but the political rights of citizens they cannot enjoy . . . .” *People v. De La Guerra*, 40 Cal. 311, 342 (A.D. 1870) (emphasis added) [in other words, **You are a SUBJECT, and have NO rights, but what are granted. by your master!**]

his native Citizenship and **adopts** a FOREIGN citizenship, (i.e. now a foreigner in the right sphere), then **tries to FORCE** (an act of war) **someone else BORN** on the left **FROM the left** political government **TO the right** political government, **THIS IS AN ACT OF TREASON!**
