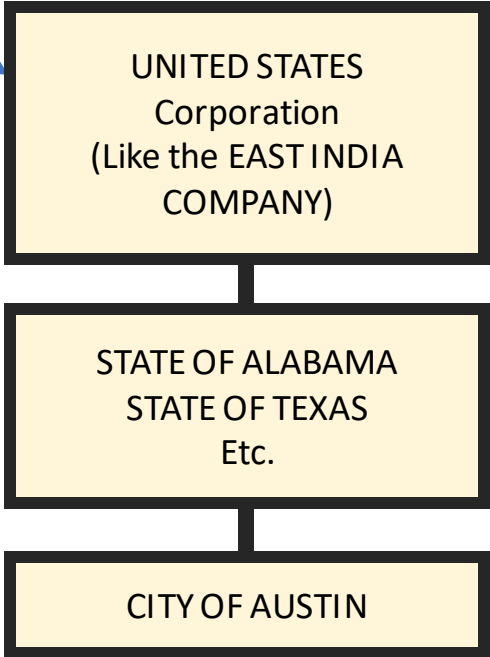
1. The 50 States are not part of 'United States'. They created it.

28 U.S. Code § 1746 - Unsworn declarations under penalty of perjury

U.S. Code Notes

(1) If executed without the United States: “I declare (or certify, verify, or state) under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.

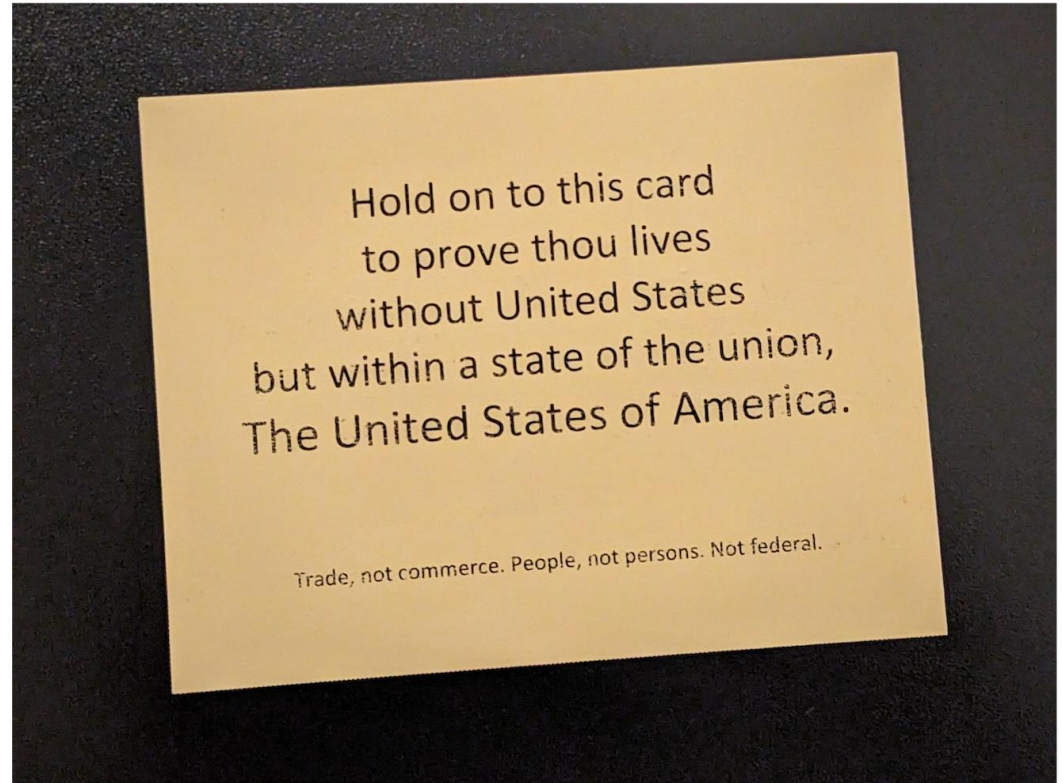
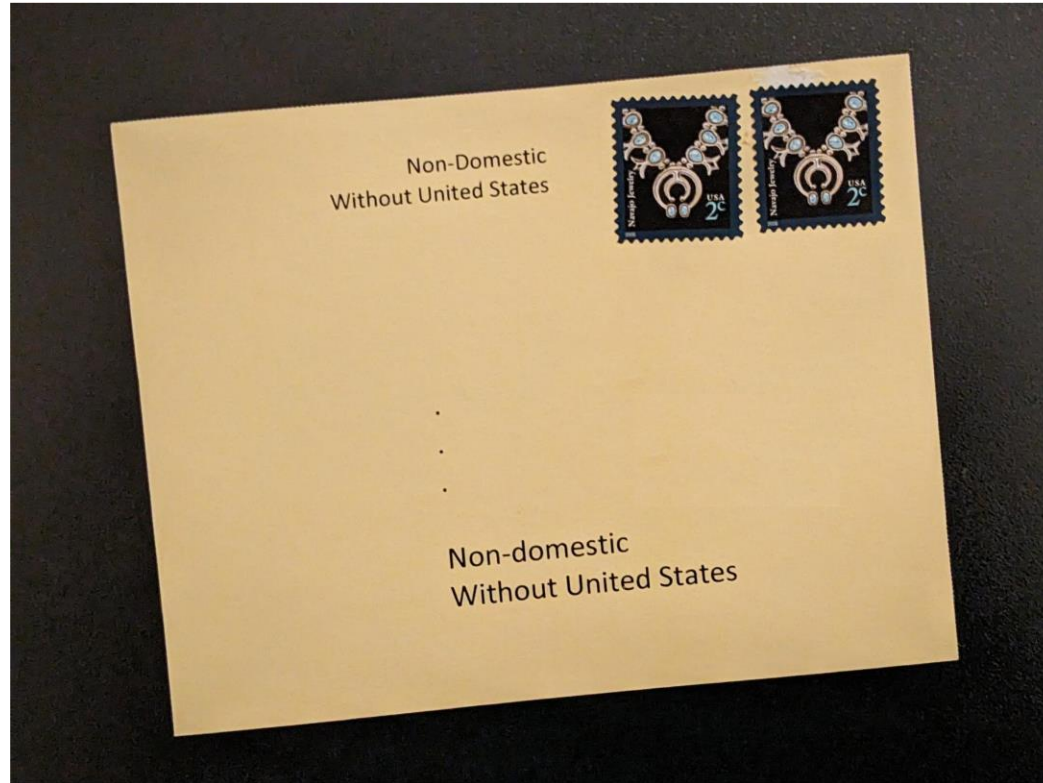

What is the postage rate ‘without United States’? About four cents.

Send 'drop letters' via the post office for two cents (I use four cents).

- Lower rate applies to letters sent 'Without United States'
- Whereas using the 'mails of the United States' costs more than 50 cents.

From bk 12 statutes at large chapter 71 section 23

postage stamps plainly annexed to such letter.

SEC. 23. *And be it further enacted,* That the rate of postage on all letters not transmitted through the mails of the United States, but delivered through the post-office or its carriers, commonly described as local or drop letters, and not exceeding one half ounce in weight, shall be uniform at two cents, and an additional rate for each half ounce or fraction thereof of additional weight, to be in all cases prepaid by postage stamps affixed to the envelope of such letter, but no extra postage or carrier's fee shall hereafter be charged or collected upon letters delivered by carriers, nor upon letters collected by them for mailing or for delivery.

Drop letters.

No carrier's fee.

UNITED STATES, Inc. (1871)

which created and controls **50 franchises** called:

STATE OF UTAH, STATE OF OREGON, etc.

Which created and control **franchises/ personas** named after living men:

JOHN HENRY SMITH

Critical mistake: John-Henry of the Smiths thinks he is JOHN HENRY SMITH and accepts the inferior role

- no questions about where father lives because mother considered unmarried

"Informant"- to claim the mom is giving away her baby. Therefore, policé report needed.

"Relation to child"- relation of informant to the child
